## MITES AND SQUIRT MINOR - FULL SEASON TEAMS (SKILL SESSIONS)

Players Tuitions \$995, 30 to 45 practices (1/2 sheets). 1 tournament, skill sessions, 18 league games. State Tournament if team qualifies. 4 to 6 pre-season August practices.

Teams will carry 15 skaters & 2 goalies & 3 alternates. Tuition for alternates is \$895 and includes practices and skills. **Town commitment IS required for the above teams.**

## PLAYER DEVELOPMENT TEAMS - FULL SEASON (SKILL SESSIONS)

### **SQUIRT MAJOR, PEE WEE MINOR, PEE WEE MAJOR & BANTAM MINOR LEVEL**

Tuition \$2695/alternates are \$1495.approx 40 to 45 games total, 30 to 33 league games. 2 practices/2 games per week on average, 1 tournament/State tournament included if team qualifies. 4 to 6 pre season practices in August.

All player development teams are National bound.

Teams will carry 15 skaters and 2 goalies, and 3 rostered alts, all games are 3-15 minute periods, there will be approx 20 off ice conditioning sessions. **Town commitment is NOT required for these teams.**

## BANTAM MAJOR, MIDGET MINOR/MAJOR ARE HALF SEASON TEAMS - All National bound.

Player's tuition \$1395 for the above teams. There will be 2 practices per week (Full sheet). 1 to 2 tournaments and 2 to 5 August practice sessions.

These teams will carry 18 skaters and 2 goalies full time. Alternates are allowed as non-rostered for practices, tuition will be \$695. **Town commitment is NOT required for these teams.**

After final tryout the Coach will inform players of a date by which they will be notified if they have been selected for the team. If you have not been contacted either on or before this date then the player has not been selected for the team.

Alternates are only guaranteed practices and skills, coach's decision on games only if player is rostered.

All players must obtain their own IMR from USA Hockey where required for Squirt Major, Pee Wee and above. Mites and Squirt Minor register through their town teams.
